Miller Color Run

The Miller Color Run Waiver is to be completed by each participant or parent of child participant (under age 19). The Miller Color Run involves running, an activity which may include risks such as, but not limited to, falls and injuries resulting from the effects of weather and conditions of the road and trail. The Miller Color Run also includes the use of powdered paint which could result in reactions for those with asthma or other breathing conditions. These activities can be vigorous and include various risks. As a participant in the Miller Color Run, I, for myself, my executor or administrator, heirs, devisees, successors and assigns hereby agree to release, indemnify, and hold harmless W. W. Miller Intermediate and Pasadena Independent School District, their management, officers, board members, employees, members, sponsors, volunteers, organizers, representatives, agents and successors, and all cooperating businesses and organizations, from all losses, claims, demands, liabilities or causes of action, known or unknown, arising out of my participation or the participation of my child in the event. In no event shall V. W. Miller Intermediate or Pasadena ISD be held liable, whether in contract or in tort, or any other legal theory, for any damages arising there from. Furthermore, I agree to indemnify V. W. Miller Intermediate and Pasadena Independent School District, for all fees and expenses incurred as a result of the breach of any contractual obligations related to, or arising from, the Miller Color Run event. I attest and verify that I am, or my child (under 19) is medically able to participate in the Miller Color Run and assume all risks of participation in this event. I understand that I may be photographed, filmed or videotaped at the event. I hereby irrevocably grant to V. W. Miller Intermediate, Pasadena ISD, and its affiliates, licensees and collaborators the absolute right and permission to use my likeness and/or voice for any purpose whatsoever. I understand that bicycles, skateboards, roller skates or inline skates, animals and non-personal music devices of any type are not allowed in this event and agree to abide by this rule. I further state that I am physically fit and able to participate in the Miller Color Run and I have trained sufficiently for this event. I also give my full permission for such first aid as deemed necessary to be provided to me or my child on the premises or prior to transport to a hospital for further treatment. I agree to stop and request assistance if I experience any symptoms such as, but not limited to, dizziness, excessive fatigue, and shortness of breath, pain or any other conditions which would make it difficult or unsafe to continue. I understand that any registration fee for the Miller Color Run is a non-refundable in case of withdrawal on my part or cancellation due to inclement weather.
